Amrut Laxmi Higher Education Loan Scheme

This Scheme is designed to assist students who intend to pursue higher education and need financial assistance. The Trust will provide assistance to most eligible student/s on the basis of rules and regulations formulated/ approved by the Managing Committee of the trust.

Eligibility : The Benefit of this scheme shall be available to those students who intend to pursue higher studies. Higher studies would mean post graduation courses such as Chartered Accountant, Cost Accountant, Company Secretary, M.B.A., MBBS, Engineering and so on.

The fees covered under the scheme will not including Lodging and boarding expenses incurred by the student.

Initially 3 students per year are intended to be selected for providing assistance under the scheme. The amount to be distributed by Trust in the first year shall be Rs. 3,00,000. For subsequent year amount and no. of student will be decided on the basis of further contributions received by Trust under Higher Education Scheme.

Amount : Each student will be eligible for Maximum Rs. 1,00,000 or 50% of the Fees payable, whichever ever is lower to pursue higher education. If a student is Pursuing a course which is spread over more than a year, the amount will be disbursed by trust of 50% of the yearly fees payable by the student.

Interest and repayment : This amount will be advanced as interest free assistance to student repayable within 1 year after completion of course for which he has taken higher education assistance from Trust.

It is expected that once student completes his study and within one year thereafter, he would return the loan provided to him along with contribution to the Higher education scheme of the Trust so that more and more student can take benefit of this scheme.

Legal : This student taking assistance from Trust would execute an Undertaking in the prescribed form undertaking to repay the amount of assistance taken by him from the trust. Legal cost of documentation etc. will be borrower/applicant's account.
